Video Submission Guidelines

We are excited that you are making a video submission for the **NEW YOU MAKEOVER**. The most important thing to remember when making your videotape is that you should keep your energy level high and have fun with this! We suggest that your video should be no more than 5 minutes in length.

The point of your video is to show us your personality and a slice of your life. **It is not recommended that you perform skits or scripted material of any kind.** Our goal is to get to know you, and your goal is to convince us that you are a perfect match for this show. Feel free to say or do anything that represents who you are and what you will bring to the show. If you are **WORKING MOM**, talk about dedication required to have a full time job and raise a family at the same time. If you are a **SINGLE MOM** than talk about how you specifically raise your family on your own. If you are the **COE** (chairman of everything) mom, than talk about all the activities you “chair”. If you are a **MILITARY MOM** talk about if you are the one in the military or if you are “holding down the fort” while your husbands stationed in Iraq or Afghanistan. If you are the “**NON-MOM**” MOM than talk about how you came into the MOM role. It’s great to back up these descriptions with some real life examples or stories.

DEADLINE: Completed applications and videotapes must be received by January 4th, 2010 at 12:00 PM ET to be considered. **Remember, the earlier the better!**

The video will become the property of the Producers and will not be returned to you, whether or not you are selected as a participant.

Applications will be considered only if they are complete. Completed applications should consist of the following:

- 1) Completed and signed Application Form
- 2) One separate photo of yourself (close up and full body shot)
- 3) Your up to five-minute videotape clearly labeled with your name, address, and phone number.

Please do not include anything except the three items listed above.

Don't forget to answer the following questions in a COMPLETE SENTENCE.

(Example question and answer)

Q. What is your favorite color? A. My favorite color is green.

2. What would you do of who would you surprise after your makeover?
3. How would you describe your life as a mother? (if applicable)
4. What inspires you?
5. What is your greatest achievement?

7. What kind of Mom are you? (if applicable) For example, the "MILITARY MOM", the "WORKING MOM", "SINGLE MOM", the "COE (Chairman of Everything) Mom" or the "NON-MOM" MOM.
8. What is something we wouldn't know just by looking at you?

It's always nice to use a few different backgrounds – (i.e. – doing something outdoorsy that you love, or any environment that you like)

Sometimes it is difficult to make the tape and fill out the application because you feel like you don't want to brag about yourself...but you have to let that go! We know nothing about you, so please **don't hold back. This is your chance to shine -- let us know what makes you special!**

When answering the questions on the written application, please be honest and be yourself. Please answer all of the questions thoroughly and honestly, and remember there are no right or wrong answers to these questions.

Some technical advice for your video:

Don't forget to make sure there is ample light and that we can hear you. It's always a good idea to turn on all the lights in the house if you are taping inside. And don't forget to turn off the TV, dishwasher and radio. If you are taping outside, make sure you are taping during the day and that it isn't too windy so that we can

hear you and ALWAYS HAVE SOMEONE ELSE TAPE YOU. The formats we prefer are VHS, mini-DV and DVD.

ELIGIBILITY REQUIREMENTS AND RELEASES

- 1) You must be at least 18 years of age and either a legal resident of the United States or otherwise legally permitted to participate in the series currently entitled "New You Makeover" (the "Series") in the United States.

proof of damages suffered by Producer and the Network in the event that I breach any of the confidentiality provisions of this application will be costly, difficult, and/or inconvenient to determine. 9) I agree that Producer may license, assign, and otherwise transfer this application and all rights granted by me under this application to any person or entity. I further agree that this application is personal to me and is not assignable by me and any purported assignment by me shall be null and void.

10) **CHOICE OF LAW.** This application shall be interpreted under the internal, substantive laws of the State of California without regard to the conflicts of law provisions thereof.

11) **MEDIATION & ARBITRATION.** The parties agree that if any controversy or claim arising out of or relating to this application cannot be settled through direct discussions, they shall endeavor first to settle the controversy or claim by a mediation administered by JAMS under its applicable rules.
